WAIVER/CONSENT FORM

In consideration for participating in YMCA of Hagerstown Activities, I hereby release, waive, discharge, and hold harmless YMCA of Hagerstown and/or City of Hagerstown, their officers, agents, and employees (hereinafter referred to as RELEASEES from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of, or related to any loss, damage, or injury that might be sustained by me, my children, or any property belonging to me, regardless of the cause; including negligence, while participating in such activity, or while participating in such activity, or while upon the premises where the activity is being conducted or in transportation to and from said premises.

I certify that I or my children's present level of physical condition is consistent with the demands of active participation. I am fully aware of risks and hazards connected with YMCA activities, including daily program transportation, YMCA field trips, swimming, emergency medical care, and authorized dispensing of prescription medications and I hereby elect to voluntarily participate in a said activity and assume the risks associated with the activity.

I further hereby agree to indemnify and hold harmless RELEASEES from any loss, liability, damage, or costs, including court costs and attorney's fees, that may be incurred due to my participation in said activity, whether caused by the negligence of RELEASEES or otherwise.

I understand that the YMCA of Hagerstown and/or the City of Hagerstown will not be responsible for any medical costs associated with an injury I or any group participant may sustain. As a parent and/or guardian, I authorize the treatment of participants as deemed necessary by medical professionals in the event of a medical emergency.

I further agree to become familiar with the rules and regulations of the YMCA of Hagerstown and the City of Hagerstown concerning my conduct or the conduct of my group participants and not to violate said rules of any directive or instruction made by the person or persons in charge of said activity. I will further assume the complete risk of any activity done by me or any group participant in violation of any rule, directive, or instruction.

This security deposit will be used to cover any damage or extended use time. The party signing the application must be 18 years or older to reserve the pool/room. The responsible group leader who signs this rental agreement must be present during the entire rental. If there are no damages/extended use, a check will be issued within **7-10 business days** to return the security deposit fee. Failure to provide two weeks prior notice of cancellation will result in the forfeiture of the security deposit. I understand the YMCA will make every effort to provide an alternative date in the event of a cancellation due to severe weather. If they are unable to do so a refund will be provided. If a party starts and unexpected weather occurs, the YMCA will consult with the responsible party. The YMCA reserves the right to cancel any party that is not in the best interest of the YMCA staff or the City of Hagerstown.

I give my permission to the YMCA of Hagerstown to use photographs, film footage, or tape recordings, which may include my or my children's image or voice for the purpose of promoting or interpreting YMCA programs. In signing this release, I acknowledge and represent that I am at least eighteen (18) years of age, I have read and understand this waiver, and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made.

POOL RULES

For the safety and comfort of our guests, our lifeguards have the authority to enforce these rules.

1. In an EMERGENCY, notify the pool manager or lifeguard on duty.
2. Lifeguards are not babysitters. ABSOLUTELY no children under the age of 15 may be left at the pool; children **MUST** be accompanied by a guardian age 18 or older while at the pool or splash pad.
3. Alcohol, tobacco, and vaping use are not permitted anywhere within the pool facility or in our parks.
4. Use of profanity in the pool area is not permitted and will cause the individual to be expelled from the pool.
5. No running, pushing, or horseplay allowed in the pool deck area. No playing on ladders/steps.
6. Deep-end use of the pool will be restricted to adults and to minors under the age of 11 that have passed the required deep-end test. The deep-end test shall consist of swimming the length of the pool, and then treading water for one minute unassisted. Upon successful completion of the deep-end test, the child will be issued a wrist bracelet indicating deep-end eligibility.
7. Equipment, such as inner tubes, floats, pool toys, etc., which may be a hazard to a swimmer shall be restricted.
8. Headphones are required for the use of any personal music devices.
9. No pets are allowed within the pool enclosure.
10. Per Health Department Regulations, proper bathing suit attire is required for pool use. (Please see attached).
11. No outside food or beverages are allowed within the pool facility at any time, except for bottled water. Pool staff reserves the right to search all bags and coolers. **No glass containers are allowed in the pool area.**
12. Patrons are expected to clean up any leftover debris from items purchased at the concession stand.
13. Food and beverages purchased from the concession stand may not be consumed within or near the pool.
14. Children who are not potty trained are allowed to use the splash pad **ONLY**. Non-potty-trained children must be wearing swim diapers under their bathing attire.
15. No swimming will be allowed during inclement weather conditions as determined by the pool manager on duty.
16. All lifeguard and management decisions are final; anyone who refuses to cooperate with the safe enforcement of the pool will be instructed to leave the premises.
17. Water Slide/Diving Board Rules
 - You must be able to swim without water wings, lifejacket/paddle.
 - One person on the slide/dive at a time. No jumping offsides.
 - Always slide down feet first.
 - All diving must be from the end of the diving board and must be straight forward, never off the side.
 - Exit the water immediately to the closest ladder.
 - No catching at the bottom.
 - Slide feet forward, no stopping or changing position.
 - No backflips or inward dives are allowed.
 - The minimum height for slide usage is 42”.
18. All rules are subject to the discretion of the pool manager.
19. The minimum supervising adult-to-child ratio is one adult to no more than six children.
20. Parents/Guardians **WILL** be held responsible for the supervision of their children **AT ALL TIMES!!!**
21. Parents/Guardians must be present at the “Splash Pad” at all times.
22. Remove all band-aids and bandages before entering the pool. Patrons with open sores, oozing, bleeding, etc. will be denied access.
23. Non-swimmer children must always have an adult in the water within arm’s reach and must remain in the water.
24. Everyone must take a shower prior to using the pools.
