

CITY OF HAGERSTOWN, MARYLAND

AN ORDINANCE ESTABLISHING SCHOOL ZONES

RECITALS

WHEREAS, the City of Hagerstown did on December 20, 2011 enact Section 60-17 to the City Code to authorize speed monitoring systems in school zones pursuant to Section 21-809 of the Transportation Article of the Annotated Code of Maryland, and

WHEREAS, pursuant to Section 21-803.1 of the Transportation Article as aforesaid, the local authority may by Ordinance establish school zones, and

WHEREAS, the City desires to establish such school zones for purposes of the speed monitoring systems Code Section as previously enacted.

NOW, THEREFORE, BE IT RESOLVED, ENACTED AND ORDAINED by the Mayor and Council of the City of Hagerstown, Maryland as its duly constituted legislative body as follows:

That the Code of the City of Hagerstown is to be amended by adding Section 60-18 to read as follows:

Section 60-18. School Zones.

1. That the City of Hagerstown pursuant to Section 21-803.1(a)(2)(ii) may establish school zones for the purpose of regulating maximum speed limits in such areas.

2. That the City of Hagerstown does hereby designate the following school zones within the City:

A. Northern Avenue within 200 yards of Fountaindale Elementary (901 Northern Ave.) and Northern Middle (701 Northern Ave.) 200 yards each direction.

B. Pennsylvania Avenue within 200 yards of Fountaindale Elementary or North Hagerstown High (1200 Pennsylvania Ave.) 200 yards each direction.

C. S. Potomac Street within 200 yards of Bester Elementary (30 E. Memorial Blvd.).

D. Memorial Blvd. for 200 yards east of Potomac Street.

E. S. Potomac Street within 200 yards each direction of Emma K Daub Elementary (1121 S. Potomac St.).

F. Salem Avenue within 200 yards of Delaware Lane.

G. Washington Avenue within 200 yards of Alexander Street.

H. Franklin Street within 200 yards of Winter Street.

I. Marshall Street within 200 yards each direction of Western Heights (1300 Marshall Street) or the Marshall Street School 200 yards each direction (1350 Marshall Street).

J. Pangborn Blvd. within 200 yards of Pangborn Elementary (195 Pangborn Blvd.).

K. Washington Street 200 yards west from Potomac Street.

L. S. Potomac Street 200 yards south of Washington Street.

M. Oakridge Avenue within 200 yards each direction of the Washington County Technical School (50 W. Oakridge) or the Antietam Academy.

3. All distances which name schools would be measured from the property line of the school property.

4. All distances involving streets would be measured from the center line of the street.

5. To the extent that the State Highway Administration has already established school zones or establishes them in the future with respect to the above mentioned schools which are different from those designated above, such State Highway Administration designations shall control.

6. Appropriate signage designating the school zones shall be erected pursuant to the Transportation Article of the Annotated Code of Maryland and the guidelines for school zones as established by the State Highway Administration.

NOW, THEREFORE, BE IT RESOLVED, ENACTED AND ORDAINED that this Ordinance shall become effective at the expiration of thirty (30) calendar days following its approval.

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF HAGERSTOWN, CHAPTER 60-18 THEREOF, *AN ORDINANCE ESTABLISHING SCHOOL ZONES*, BY ADDING A NEW SCHOOL ZONE, AND TO MAKE OTHER AMENDMENTS CONSISTENT THEREWITH

RECITALS

WHEREAS, on or about December 20, 2011, the Mayor and Council *enacted* Chapter 60-17 to the City Code to authorize the placement of speed monitoring systems in school zones pursuant to §21-809 of the Transportation Article of the Annotated Code of Maryland;

WHEREAS, pursuant to §21-803.1 of said Article, a local authority, including the City of Hagerstown, may by Ordinance establish school zones;

WHEREAS, on or about March 13, 2012, the Mayor and Council *enacted* Chapter 60-18, an Ordinance Establishing School Zones in the City of Hagerstown; and

WHEREAS, the Mayor and Council desire to amend the aforesaid Chapter 60-18 to establish a new school zone, for the purpose of placement of a speed monitoring system, as previously enacted; and

WHEREAS, the Mayor and Council find it to be in the best interests of the citizens of the City of Hagerstown to do so;

NOW, THEREFORE, BE IT RESOLVED, ENACTED AND ORDAINED by the Mayor and Council of the City of Hagerstown, Maryland, as its duly constituted legislative body, as follows:

Section 1. The Code of the City of Hagerstown be and is hereby amended by adding new language to Chapter 60-18.2. School Zones, by adding the following additional school zone at the end of that section as follows:

N. Hagers Crossing Drive within 200 yards of Jonathan Hager Elementary School (12615 Sedgwick Way).

Section 2. The Code of the City of Hagerstown be and is hereby amended by adding Section 60-18.7. as follows:

60-18.7. In accordance with §21-809(b)(1)(v) of the Transportation Article of the Annotated Code of Maryland, this Ordinance must provide that when a speed monitoring system is placed in a location where one had not previously been moved or placed, the City may not issue a citation until (1) signage has been installed in accordance with §21-809 of said Article; and (2) for at least 15 calendar days after said signage is installed.

Section 3. Effective Date. This Ordinance shall become effective immediately upon the effective date of this Enacting Ordinance.

BE IT FURTHER RESOLVED, ENACTED AND ORDAINED that this Enacting Ordinance shall become effective at the expiration of thirty (30) calendar days following its approval.
