I acknowledge that repair and replacement of the public-right-of-way with appropriate permits and inspections are my responsibility.

I certify that I am properly registered and licensed as required by the City of Hagerstown and the State of Maryland.

INVESTIGATION FEE: Any person who commences any work on a plumbing system before obtaining the necessary permits shall be subject to 100% of the usual fee in addition to the required fees.
